Consignment & Selling Agreement

REAL DEAL COLLECTION provides authentic pre-owned luxury bags and accessories for sale in our Santa Fe, New Mexico showroom boutique, our website, and other selling venues. We offer three (3) ways to sell your item(s): direct buy cash, trade-in for store credit, and consignment sale. Please carefully read the terms outlined below regarding our policies.

Item Criteria

- 1) Authentic designer brand, such as:

- 2) New to used condition without significant defects*.

*Any repairs must have been made by the designer's authorized repair center.

- 3) Bags, luggage, jewelry*, accessories (belts, charms, key rings, scarves, sunglasses), small leather goods (agendas, coin pouches, cosmetic cases, holders, wallets) and unworn shoes.

*Jewelry must not have missing stones or broken parts. Watches must be in working order.

- 4) Resale value greater than \$75 for direct buy or trade-in offers, and \$500 for consignment sale.

Process

Upon receipt of your item(s) Real Deal Collection will be responsible for the promotion, care and associated customer service to sell, including: authentication, resale market price evaluation, detailed description, professional photography, online posting, email promotion, answering customer inquiries, secure packing, shipping and insurance. We will take all necessary steps to sell your item(s) quickly and at the best price possible.

Payments

We make payments via bank checks sent through US Mail, or picked up in our boutique, and electronically via PayPal Personal Payment. All payments are made after our authenticators have certified authenticity. Please note that authentication may take several days, depending on the item. Consignment payments are made at least once a month, after the sales transaction is complete, subject to our return and layaway policies.

Please note that direct buy cash and trade-in store credit offers must be accepted within 14 days of the offer date due to market fluctuations.

Selling Option 1: Direct Buy Cash

We pay fair cash value outright for select items with resale values over \$75. Typically, direct buy offers will be approximately 40% to 50% of the estimated resale value. Direct buy is the quickest and easiest way to sell your luxury goods.

Selling Option 2: Trade-In Store Credit

We issue immediate store credit for select items with resale values over \$75. Typically, trade-in offers will be approximately 50% to 60% of the estimated resale value. You do not have to wait for trade-in items to sell. Once accepted store credit never expires.

Selling Option 3: Consignment

We sell select items with resale values over \$500 on a consignment basis. Our low commission is just 30% of the price sold, plus a \$25 handling fee, per item. In other words, your payment is 70% of the price sold less \$25, for each item we sell on consignment. Consignment items are subject to our 14-day return policy or 30-day return policy if sold thru eBay, and may take up to 90 days with our layaway installment payment plan which is a final sale and not returnable. After an item's sales transaction is complete, we will send you an email detailing the sales record.

Consignment Term & Item Pricing

We require a minimum of 120 days from the date of this signed agreement for consignments. We reserve the right to offer a 10% discount at any time as a sales incentive if needed.

- Item pricing is determined by our research and approved by you.
- After 60 days, the item may be discounted another 5% to 10% off.
- After 90 days, the item may be discounted another 5% to 10% off.
- Please let us know if you wish an additional discount at any time.

Consignment Cancellation

Due to the work, expense, and time invested, there is a \$50 cancellation fee, plus shipping for each item you want returned before 120 days from the date of this agreement. If unsold after 120 days, you may request for us to return any items to you at our expense, or you can allow items to remain for sale for an additional period of time.

Disclaimers

Although we take every precaution to protect your items against loss or damage while they are in our care, Real Deal Collection is not responsible in the event of theft, fire, flood, or act of nature while in our possession. We will file an insurance claim with our insurance company to recover damages for your loss, but we cannot guarantee that you will recover any monies.

Any item that we cannot authenticate with complete confidence will not be accepted. We reserve the right to refuse any item that does not meet our standards and it will be returned to you at the cost of shipping, or picked up in our showroom boutique.

We are not responsible for any item lost or damaged by the carrier during shipment to us. Please be sure to pack your items securely and send parcels with a tracking number, signature upon delivery and insurance. International clients are responsible for any import taxes, customs fees or handling fees associated with international deliveries. The U.S.A. duty-free limit is \$200 USD.
